Includes hands-on activities, brainstorming and more.

Part II - Cost Analysis

A 2-hour workshop highlighting how to calculate and analyze: Start-up Costs ~ one time expenses, needs versus wants, creating an accurate list; Operating Expenses ~ fixed and variable costs, calculating accurate projections, monthly costs, and business financial viability essentials in obtaining a loan, identifying capital, and planning for direction.

Part III - Funding Your Small Business

A 2-hour workshop focusing on how to access funding through various sources including: SBA guaranteed loan programs, traditional/conventional bank loans, crowdfunding, online sources, investments and family and friends. You will get an overview of the types of loans available and how to use them, investment procedures, legal structure, how to prepare for loan opportunities, what you need to know and the documentation that you will need to apply.

Part IV - Business Plan

A 2-hour workshop concentrating on an overview of the business plan, purpose, content and preparation for obtaining a loan or for better direction. Topics include: business description, products & services, market information & analysis, promotion, management and personnel, facility, financial statements, and projections and future planning. You will learn how to incorporate information from the three sessions into a concise business plan.
